This will enable the club to calculate the outstanding remainder of your Swim England membership and insurance which is payable to them upon departure.

Data Protection Act 2018

The Data Protection Act 2018 ("the Act") sets out certain requirements for the protection of your personal information (i.e. Information about you), against unauthorised use or disclosure. The act also gives you certain rights. The club holds information on members and is asked to submit extracts of this information to the Swim England. We adhere to the data privacy policy. Please read the Swim England Data Protection notice which can be found on their website at <http://www.swimming.org/library/documents/2479/download> and by signing this form you are agreeing to this data being held and supplied to the Swim England where necessary.

Details relating to disclosure of disabilities and medical conditions and medication taken are not covered by the Data Protection Act. Hence Nottingham Northern Swimming Club agree that only relevant club members (e.g. Head Coach, Lane Coaches, team managers, Welfare Officers) will be made aware of any disability or medication your child/children are receiving. By signing this form you are consenting to this information being made available to these members.

Responsibility of Swimmers

It is important that parents are clear where Northern's responsibility starts and ends during a swim session. Parents are always requested to be on site during the session but on occasion, this may not be possible. In this instance, they must nominate another person to be responsible for the swimmer.

Harvey Hadden: coaches/committee will be responsible for swimmer's whist on poolside and in the group changing rooms. Parents take responsibility if they use public changing rooms as soon as the session ends.

Ken Martin: coaches/committee will be responsible for swimmer's whist on poolside but parents will take responsibility when the session ends.

High School: coaches/committee will be responsible whist on poolside and in the group changing rooms for a total of 10 minutes after the session has ended.

I acknowledge and accept the full responsibility for the care and safety of my child/children by ensuring myself/nominated carer over 18 years is in attendance during each swimming session.
